



Membership Contract

Please carefully read the membership guidelines below.

All members must agree to follow:

Based on the rapid growth and success of Mom4Profit it is now time to revisit the guidelines and implement policies that will hopefully allow us to continue to prosper and even expand into other regions.

The following provisions represent the new guidelines we intend to implement. All members must agree to follow the guidelines in order to maintain membership. All memberships will be reviewed on an annual basis to determine compliance with the following guidelines. The Executive Committee will have discretion to renew or not to renew the membership of each member.

MEMBERSHIP

1) Becoming a member.

All new members must be approved by the Executive Committee. Each member will complete a registration form and provide information about themselves and their business. In order to be considered for membership, a member must be a business in good standing for at least one (1) year. The executive Committee reserves to the right to deny membership in their discretion.

Unless otherwise agreed on by the members being affected and the Executive Committee, any new member may represent a trade, industry or service that is not already represented by an existing member. If a conflict of does occur, current members and prospective members should contact the current membership committee to make a determination.

2) Committee Participation.

All members are invited to participate on a sub-committee (of their choice). Members may serve on more than one committee.

3) Behavior.

All members are expected to behave in a respectful manner at all times. No member shall speak disparagingly about another member orally or in writing. Members shall support each other and mom4profit in the community by speaking positively about each other and mom4profit and promoting the businesses of all members. Members are expected to respond to communications with each other in a timely manner. Members are encouraged to contact members of the Executive Board to help resolve internal issues or conflicts between members. Members are also encouraged to promote and support mom4profit businesses first and refer business to mom4profit members rather than outside businesses.

4) Referrals

Members shall refer business to other members as frequently as possible. Each member is recommended to make at least six (6) total substantial referrals among at least three (3) different members. New members' referral responsibility will be prorated at the discretion of the Executive Committee. Members are highly encouraged to use each other's services in order to better recommend and refer them to others.

COST

Mom4Profit charges a membership fee. The fee will be \$60.00 annually, due the first of September each year. If a member joins in the middle of the year, their fee will be prorated on a monthly basis accordingly. In addition to membership fees, each member may be required from time to time to pay additional fees that may arise in connection with Mom4Profit events. Such fees may be required to pay for use of a display table for the member's business, site rental, supplies, advertising and marketing, etc.

MEETINGS

Members are required to attend the monthly meetings. Members are expected to be on time to each meeting and should respond in advance as directed on Facebook. A sign-in sheet will be provided at each meeting and each member will be responsible for signing the sign-in sheet. Each member may miss up to three (3) meetings per year. However, no member may miss more than two consecutive meetings. Additional missed meetings may cause the member to lose her membership with no refund of the membership fee. In order to hold your position/industry within mom4profit a \$25.00 fee will be charged for every meeting missed after the 3 excused absences. Members cannot have anyone "represent" them in meetings unless they are business partners.

Prospective members may attend one (1) free meeting before joining as a regular member. If the prospective member decides to join and is accepted by the Executive Committee, said member will be required to attend all future meetings and will be subject to the attendance rules.
